

FREQUENTLY ASKED QUESTIONS

While the Official Rules outline the complete details of this promotion, you may find additional answers to your questions below.

How do I register for the sweepstakes?

- Visit your financial institution's website and click on the 'Discover Digital' banner. Follow the instructions on the Discover Digital microsite to register for the promotion. You must register to participate and receive qualifying entries into the sweepstakes.
- Non-customers (or customers who do not wish to register through their financial institution's website) should view the <u>Official Rules</u> for instructions on the Alternate Method of Entry.

How does the sweepstakes work?

- Existing or New End Users ("Entrant") of participating financial institutions will earn (1) entry for each eligible Online or Mobile Banking digital transaction during the sweepstakes period:
 - Enroll in Online or Mobile Banking (enrollment of new users only)
 - Mobile Banking alerts enrollment*
 - eBill enrollment*
 - Complete a Mobile Check Deposit*
 - Every time you log in to Online or Mobile Banking

• Entries are further divided into three (3) monthly periods as defined in the chart below.

Who can participate?
