## **HOW TO ENTER:**

### There are two ways to enter the Sweepstakes:

#### 1 A Online/Mobile Banking Automatic Entry:

If entering by mail you do not need to register for the promotion but you must be a member of a participating financial institution. To enter without signing in to your participating Financial Institution Online or Mobile account during the Sweepstakes Period, hand-print your name, address, city, state, zip code, daytime phone number, the name of your financial institution (name only, no account numbers), and email address (mandatory) on a plain 3"x5" piece of paper, place in a stamped envelope and mail to: NCR Discover Digital Sweepstakes, Sweepstakes, P.O. Box 490, Woodbury, NY 11797-0490. Mail entries must be postmarked by June 30, 2017 and received by July 6, 2017. Limit of one entry per mailing envelope.
